## AML Updates in NZ

There is so much going on in the NZ AML landscape just now that we have written a blog on it! In short:

- Stage 3 of the [AML Amendment Regulations](#) comes in on 1 June, with a focus on making sure you give your clients an actual risk rating. Also, make sure you have updated your documentation and processes for the Stage 1 & 2 changes!
- The [Statutes Amendment Bill](#) is an Omnibus Bill that rolls up lots of changes to different Acts. Part 2 deals with AML changes. It is expected to come into force later in 2025.
- The [AML/CFT Amendment Bill](#) is a significant set of changes in three parts. It is currently in Select Committee stage, with the report expected in August 2025. It proposes many changes including making **the DIA the sole AML Supervisor** for New Zealand, as well as bringing in a **Reporting Entity Levy** to help fund government activities.
